### PASSES ARE NON-TRANSFERABLE AND MUST BE USED WITHIN THE 2011 SEASON.

Your valid Tahoe Donner ID card must be presented to the Golf Shop staff each time you register to play. Property owners may reserve tee times beginning at 5:30 p.m., up to 14 days in advance, by using the ForeTees online reservations system (exclusive for TD members), or in person, or by calling the TD Golf Shop at (530) 587.9440, ext. 3. Public may call to reserve tee times up to 12 days in advance. TDA property owners will be required to provide a unit and lot number, a phone number, and credit card information to secure a reservation. You must be a member in good standing at the time of play. Cancellations or reductions to the number of players reserved must be made directly to Golf Shop staff at least 24 hours in advance of scheduled tee time, or you will be charged accordingly. Season pass holders will be charged the applicable daily rate if they fail to cancel their reservation. Golf Season passes are not valid for any outside tournament play. No full or partial refunds, or other considerations, will be given should you be unable to use your golf pass, or should you sell your property during the 2011 golf season.
