#### SUMMARY

The Water Safety Instructor Aide is responsible for assisting the Water Safety Instructor in organizing and instructing American Red Cross format swim lessons up to Level III.

**ESSENTIAL DUTIES AND RESPONSIBILITIES** include the following. Other duties may be assigned.

Provide excellent customer service to customers, employees and business partners.

Maintain current knowledge, implement and enforce Association policies, procedures, rules and regulations.

Open and/or close pool facilities including removing and replacing pool covers. Ensure pool equipment is in proper working order.

Assist Water Safety Instructor in evaluating students and determining appropriate swim technique to instruct.

Assist Water Safety Instructor in demonstrating proper swim techniques to students in swimming pool.

Assist Water Safety Instructor in implementing American Red Cross based lesson plans.

Assist Water Safety Instructor in preparing class materials and assists in set-up and take-down of swim lesson equipment and materials used daily.

Cooperate and communicate with co-workers effectively.

Ability to work some evening hours.

Attend and participate in mandatory in-service training and meetings.

Work well in a group/team environment.

### PHYSICAL DEMANDS

The employee must frequently lift and/or move up to 25 pounds and occasionally lift and/or move up to 100 pounds. Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception, and ability to adjust focus.

### WORK ENVIRONMENT

While performing the duties of this job, the employee is regularly exposed to wet and/or humid conditions, extreme heat and outside weather conditions.
