

#### Common Areas treated 2012 to 2016







The Forestry 5-year plan is budget based and for a "NORMAL" year. For 2017 there is \$364,121 available for forest and fuels projects. The targets set in the Forestry 5-year plan are treatment of 60 acres of fuel break/plantation and 100.2 acres of common area.

#### Drought Caused Tree Mortality

Average year	100 to 150 trees
2015	641 trees
2016	577 trees

Even after the wet winter we just experienced, forest pest management specialists agree that we will continue to see higher than normal tree mortality due to bark beetle activity.
