### **SUMMARY**

Under the direction of the Cross Country Manager, the XC Ski Instructor Level I is responsible for teaching adult and children ski classes and assisting with ski school organization.

### ESSENTIAL DUTIES AND RESPONSIBILITIES include the following.

- Provide excellent customer service to customers, employees and business partners.
- Teach adult and children ski classes in cross country techniques appropriate to the student or group's abilities, fitness and needs.
- Seek opportunities to improve current knowledge of teaching and skiing techniques.
- Assist ski school students with proper ski equipment use and proper ski techniques.
- Assist checking trail users have a season pass or day ticket.
- Assist with rental shop service, customer information, and retail as needed.
- Assist with area set up, races, promotions and special events as needed.
- Assist with snow removal including shoveling and clearing snow from walkways, stairs, equipment and other areas as needed.

### **QUALIFICATIONS**

### **EDUCATION and/or EXPERIENCE**

One year certificate from college or technical school; or three to six months related experience and/or training in the ski business; or equivalent combination of education and experience.

Current Professional Ski Instructors of America (PSIA) cross country certification Level I, or equivalent cross country teaching ski experience required.

Current Professional Ski Instructors of America (PSIA) membership recommended Current Cardiopulmonary Resuscitation (CPR) and First Aid certifications recommended.

### LANGUAGE SKILLS

Ability to write routine reports and correspondence. Ability to communicate effectively with groups of customers or employees of organization ad and interpret documents such as safety rules, operating and maintenance instructions, and procedure manuals.

### MATHEMATICAL SKILLS

Ability to calculate figures and amounts such as discounts, interest, commissions, proportions, percentages, area, circumference, and volume. Ability to apply concepts of basic algebra and geometry.

### REASONING ABILITY

Ability to apply common sense understanding to carry out instructions furnished in written, oral, or diagram form. Ability to deal with problems involving several concrete variables in standardized situations.
