Content must not deal with matters of litigation, contain profanity or refer to the election of candidates to the board of directors. Letters from committee members, active directors, and candidates running for the board of directors will not be considered for publication. In addition, their participation in any way in the preparation of letters by others is considered inappropriate. No anonymous or "request for name withheld" letters will be published. Letters not meeting these requirements will not be published.
