

DECISION PAPER

Issue:

As required by the Covenants and Restrictions, changes to Covenants Fine Schedule must go out for 45-day member notification prior to board consideration and approval.

Background:

Pursuant to Tahoe Donner Covenants and Restrictions Article XIII Section 6(b) Schedule of Fines, modifications to the Covenants Fine Schedule must go out for 45-day member notification prior to board of director consideration and approval.

At the November 8, 2018, Covenants Committee meeting the committee reviewed the Covenants Fine Schedule. The committee has not made any changes to the fine schedule in more than eight years. The committee discussed the fine schedule and discussed if higher fines would be more effective for deterring violations and gaining compliance.

The committee agreed to propose the following changes to the Covenants Fine Schedule for the board of directors to consider approving for a 45-day member notification prior to board consideration and approval:

- Increase the Private Property Fine Schedule for 1st, 2nd and 3rd violations.
- Separate the Noxious Activity fine and increase fine by creating a minimum to maximum range for the first offense, doubling thereafter.
- Separate the Business Activities fine and increase fine and create a minimum to maximum range first offense, doubling thereafter.
- Increase the Tree and/or Vegetation Removal minimum fine value.
- Increase the General Common Area and Amenity Rule Fine Schedule.
- Increase the Vegetation Removal minimum fine value.
- No change to the Fire Safety violation range.

Options:

Option 1: Make no adjustments to existing Covenants Fine Schedule for 2019.

Option 2: Consider approving for 45-day member notification for changes to the Covenants Fine Schedule for 2019 as presented below.
