**WHEREAS**, the services of Justin Malley have recently been engaged in the capacity of Director of Finance and Accounting of Tahoe Donner Association;






**NOW, THEREFORE, BE IT RESOLVED**, The Board of Directors hereby approves the following key executive and signatory changes to the following Association financial accounts,


