I. Opening Business (3:00 pm) Peter Sawyer

- Call to Order/Quorum Call: Peter Sawyer called the meeting to order. Nine of the twelve Committee members were present (see above)
- Member Comments: None
- Comments of Committee Chair: Peter stated that he participated in the Director's Information Session on April 17. He gave an overview of the Committee, including the fact that Tahoe Donner members rate the Trails as the #1 'Amenity.' He explained the purpose and general findings of the Dog Management Subcommittee.
