

# **KEY STRATEGIC CHANGES:**2013 vs 2022 TRAIL MASTER PLANS





- The 2013 TMP emphasized multi-use trails and improved trail standards to create a more consistent experience across the trail system.
- The 2022 TMP sought to broaden the diversity of experiences available on the trail system:
  - Building designated use trails and zones
  - Introducing new design methods
  - Allowing directional trails

### **CURRENT FOCUS**

Wayfinding and etiquette signage

Address 1<sup>st</sup> mile out from the ACAC trailhead with designated use trails and zones

Trail data collection

Working with adjacent landowners to connect trails and open space

Create new experiences, improve usage patterns, through trail designation + trail construction

## **IMPROVEMENT RECOMMENDATIONS**

The 2022 Trails Master Plan (TMP) recommends approximately 50 trail improvement projects for all users.\*


### RECOMMENDATION CATEGORIES

  - Ex. Frog Lake Connection
- New Paved Class 1 Trails
  - Ex. Trout Creek Class 1 to ACAC and DH
- New Dirt Trails
  - Ex. Family Flow Trails, Sunrise Bowl, new section of Rawhide, new Alder Creek boardwalk
- Improve Existing Dirt Trails
  - Ex. Alder Creek and East Perimeter
- New and Improved Trailheads
  - Ex. Teton Way Trailhead



### Trail Master Plan - Compiled Map of Improvements





This map shows a compilation of the proposed improvements to the Tahoe Donner trail system. Subsequent maps show the focused improvements.

Conceptual trail recommendations are expected to evolve in response to new information and new opportunities and in response to evolving needs and trail usage. Conceptual recommendations must also be designed and constructed to avoid environmental and archaeological concerns.

- May include studies, building/grading plans, permits if needed, etc.

- Teewinot single track connection <u>all users</u> .5mi.

- Hidden Gem heavy maintenance for <u>all users</u>.
- NEW Wild West Uphill uphill travel-only trail for all users 1.25mi.
- Cinnamon Twist/Moondance Hut single-track connection for <u>all users</u>- 500ft.
- Boardwalk at ACAC hike/bike. 300ft.
- Decomposed granite/rock lined trail from ACAC boardwalk to dirt road <u>all users</u> 900 feet.
- Small realignment of bottom True Grit better connection to Moondance Hut. bike only 250ft.
- NEW Rawhide connection Moondance hut to Alder Creek road horse hike .35mi.
- Small connection to Pookers- creating a better connection from Moondance Hut- all users. 447ft.

### PLANNED DEVELOPMENT FUND PROJECTS

- Install all new trail wayfinding and trailhead kiosk signage across the entire trail network – all users
- Construct better connections for Cinnamon Twist and West Euer Valley trails into Coyote Crossing – all users
- Construct a new family flow bike trail (TMP p.52 and 53) bike
  - Scope: This project will be built in the vicinity of Alder Creek Adventure Center where there is ease of access to restroom facilities, food/water, emergency services, the Bikeworks rental and gear shop, and bike camps.

# **NEW FAMILY FLOW + EQ/HIKER ONLY TRAILS**

### New Trails Achieve TMP's Strategic Goals:

- Build trails that activate the use of ACAC
- Create single-use trails in dense use areas
- Develop focused zones close to facilities


### **Design Considerations:**

- Consistent with TMP strategic goals
- Trails meet contemporary design standards
- Keeps youth camps and families closer to facilities, not Euer Valley
- Staff sought to use the visually impacted powerline, road corridor, and tree plantation for flow trail bike feature construction
- New 0.96-mile "Flying Squirrel," one-way bike only trail does not overlay existing designated hiker/horse only trails
- New 0.95-mile "Silver Streak and Downward Dog" designated hiker/horse only trail moves towards quieter, more natural settings off Bear Meadows and Aspens









# FLOW TRAIL ALIGNMENT

Key Design Considerations:

A primary goal for the flow trail was to change mountain bike usage patterns by concentrating mountain biking on a designated use mountain bike-only trail. The short conceptual trails would not have been attractive enough to mountain bikers long-term to achieve this goal.

The extended flow trail also creates a loop with True Grit (designated bike only in 2023). This loop also helps focus mountain biking use onto specific trails in this area, making other trails less impacted by bike traffic.

# **Tahoe Donner Equestrian Trails and Proposed** 0.25 0.5 Miles

# **EQUESTRIAN ZONES**

The TMP sets aside 95.6 acres of land for equestrian use in addition to 3 miles of existing designated equestrian trail.

For Comparison:
Golf Course = 66 acres
DH Ski Area = 82 acres

Over the coming years, longdistance horse and hike-only trails are planned to be constructed or redesignated.

The 2022 TMP member feedback showed that hikers do not necessarily desire to share trails with horses.

### REVIEW PROCESS MOVING FORWARD

#### STAFF



- Trails Master Plan IMP
- Management Plan Yearly Implementation and 10-Year Project Outlook Yearly Projects Implementation subject to annual review and updating
- Member engagement through communication plans and project site walks

# TRAILS AND OPEN SPACE COMMITTEE



- Reviews and advises on TMP, Trails Master Plan IMP, and Land Management Plan, and Land Management departments' operating budgets
- Reviews and advises on trails and open space member feedback

# BOARD OF DIRECTORS

- Governance oversight
- Reviews and approves Plans, Annual Budgets, policies and regulations, etc.

### Process Improvements:

Project Sheets detailing project, scope, cost estimate, TMP alignment and/or if diverges from TMP provide justification.

When a project proposes to diverge from the TMP, special care will be taken to engage and communicate at the member, committee, and board levels.






Local and Regional Trail access due to seasonal snowmelt and closures.



### TRAILS MASTER PLAN IMPLEMENTATION PLAN (IMP)

- Equestrian Focus: Design Workshop and Pegasus Consultants under contract to facilitate meetings and recommendations regarding equestrian needs and facilities to inform the Trails Master Plan IMP, Capital Plans, and EQ operations.
- Operational Focus: Trail Management Plan, a sub-document that identifies operation standards, prioritization, and implementation of the TMP.
- Project Focus: 10-year project outlook detailed project list including existing and new trails, trailheads and other ancillary facilities, scope of work, estimated costs, etc.

Staff, Trails and Open Space Committee and its subcommittees, consultants, and the Board for final review and approval of the Trails Master Plan IMP.
