


BACKGROUND

Tahoe Donner has several active committees made up of members who are in good standing


By collaborating with the Board of Directors and staff, committees work to:

ARCHITECTURAL STANDARDS – 3 Members, 2-5 Alternates (Two-Year Terms)

- As of December 31, 2024, the Architectural Standards Committee (ASC) will have:
