The Board had consensus to move forward with an 8 month period (for 2024 only) Rec Fee to May 1, 2024 through December 31, 2024, and then moving to a January through December calendar starting in 2025.

The Board asked the Finance Committee to look at the 2021 Surplus options and to provide a recommendation to the Board next week.
