The application for candidacy is a fillable PDF form and can either be (1) filled in and signed electronically and saved as a PDF and emailed or (2) printed out, filled in by hand, scanned and saved as a PDF and then emailed. In either case, the PDF of the application for candidacy and the proof of ownership must be sent to electionscommittee@tahoedonner.com by 12PM on April 17, 2026.

2. **Candidate Solicitation Announcement:** This document serves as an invitation to become a candidate, and it delineates qualifications for candidacy and key information provided in the Tahoe Donner Association Election and Voting Rules and Bylaws.
3. **Specifications for the Director Election Statement:** The *Director Election Statement* must be sent as a PDF to electionscommittee@tahoedonner.com by 12PM on April 30, 2026. It will be posted on the Tahoe Donner Board Election website and a black and white printed copy will be included in the mailed Voter Packet.
