RE: **Member Advocate Verification Form and Related Documents**

Any Tahoe Donner Association Member who wishes to express a viewpoint related to the 2026 Directors Election via Tahoe Donner Association communication media may apply to be a Member Advocate. The Member Advocates may have equivalent access as Director Election candidates if they comply with the specified requirements.

The communications opportunities for Member Advocates related to the 2026 Director election are:

- Provide a PDF of *Director Election Statement*.
- Provide a Director Election-related personal website URL link which will be posted to the Tahoe Donner Elections website.
- Provide a Director Election personal email address which will be posted to the Tahoe Donner Elections website.
- Provide a color headshot which will be posted to the Tahoe Donner Elections website.
- Speak at the Director Election Forum following all the candidates.

To be eligible to participate in this manner, Member Advocates must timely complete a Member Advocate Verification form accompanied by proof of their membership status.

If the Member Advocate wishes to speak at the Director Election Forum following all of the Candidates, they must notify the Elections Committee of their intention by **12PM on April 30, 2026** by sending an email to [electionscommittee@tahoedonner.com](mailto:electionscommittee@tahoedonner.com).

This Member Advocate Packet webpage contains the following items:

1. **Member Advocate Verification Form:** This form must be signed and be accompanied by your Proof of Ownership (Certificate of Ownership – Recorded Grant Deed).

The Member Advocate Verification form is a fillable PDF form and can either be (1) filled in and signed electronically and saved as a PDF and emailed or (2) printed out, filled in by hand, scanned and saved as a PDF and then emailed. In either case, the PDF of the form and the proof of ownership must be sent to [electionscommittee@tahoedonner.com](mailto:electionscommittee@tahoedonner.com) by 12PM on April 17, 2026.

2. **Candidate Solicitation Announcement:** This document is directed to Candidates. It is included in the Member Advocate packet because the information about the *Director Election Statements* is applicable to Member Advocates if they choose to submit a *Director Election Statement*.

3. **Specifications for the Director Election Statement:** The *Director Election Statement* must be sent as a PDF to [electionscommittee@tahoedonner.com](mailto:electionscommittee@tahoedonner.com) by 12PM on April 30, 2026. It will be posted on the Tahoe Donner Board Election website and a black and white printed copy will be included in the mailed Voter Packet.
